Since the Church herself is both a sacrament—that is, a sign of God's saving action in the world—and the place where the sacraments take place, two of the chapters are about the Church, the body of believers where God dwells.

The fall of Porfirio Díaz has traditionally been presented as a watershed between old and new: an old style repressive and conservative government, and the more democratic and representative system that flowered in the wake of the Mexican Revolution. Now this view is being challenged by a new generation of historians, who point out that Díaz originally rose to power in alliance with anti-conservative forces and was a modernising force as well as a dictator. Drawing together the threads of this revisionist reading of the Porfiriato, Garner reassesses a political career that spanned more than forty years, and examines the claims that post-revolutionary Mexico was not the break with the past that the revolutionary inheritors claimed.
