Hold the otoscope like a pen between the thumb and index finger; Use your right hand for examination of the right ear and left hand for the left ear; Slowly insert around 1-1.5cm just past the hair of the lateral canal; Gently pull the pinna upwards, backwards and outwards Be careful!

Ear Examination - Oxford Medical Education When the Weber's test lateralises to the affected ear and the Rinne's test demonstrates bone conduction greater than air conduction, one can usually assume a conductive hearing loss in that ear. If significant asymmetrical sensorineural hearing loss is present, the Weber's test often lateralises to the unaffected ear and the Rinne's test demonstrates air conduction greater than bone conduction.

With unilateral peripheral vestibular loss (like labyrinthitis or vestibular neuritis), the eyes cannot maintain focus, and a saccade (quick rotation of the eyes from one fixation point to another) will occur bringing the eyes back to the examiner's nose.

Dizziness - History and Examination | Epomedicine Introduce yourself and confirm the patient's name and date of birth. Explain the procedure, check the patient's understanding and obtain consent. Proceed to wash hands. Preferably, the patient should be seated in a chair so that you have easy access to both sides during the examination.
